**FOI 2024-G-008 – Privacy Practices (UHT)**

Dear Mr. Heughan:

This letter is in regards to your request made under the Freedom of Information and Protection of Privacy Act formally received by our organization on July 11, 2025 for access to certain hospital records as follows:

*On July 23rd, 2023, at approximately 4:30 am, a clinical assistant (CA) was assigned to attend to the body of Josephine Victoria Heughan (nee Lonsdale), who was recently deceased in room 60, on the 14th floor of St. Michael's Hospital. Josephine's son, Anthony Heughan, was in attendance and personally witnessed what transpired.*

*In the process of moving Mrs. Heughan's body, the clinical assistant yanked the protective underwear from her so fiercely that her head was thrown violently at the metal siding of the bed. Her temple smashed against the railing so forcibly that another patient, who had been sleeping, was awakened with a fright and immediately sat up in bed.*

*This vicious and unethical act constitutes "indignity to a human body".*

*When Mrs. Heughan's body arrived at the Funeral Parlour, there were questions asked of her son about why there was a large haematoma (a yellow lump caused by blunt force) on her face.*

*As Private Prosecutions are currently in the process against two doctors of St. Michael's hospital, Doctor Seema Marwaha and Doctor Michael Sklar, we have been advised that the said clinical assistant should be included in the proceedings.*

*Samantha Edgar, the Patient's Relations Specialist at St. Michael's Hospital, has refused to release any information the CA without a formal request. This is that request.*

***Please release the name of the clinical assistant who "attended to" Josephine Victoria Heughan (Lonsdale) in a timely manner so that the proper charge can be laid.***

A request under the Act usually must be answered within 30 calendar days, however section 27 of the Act allows for time extensions under certain circumstances. The time limit for answering your request has been extended by 30 days as the search through records and meeting the time limit would unreasonably interfere with the operations due to resource limitations and constraints. Although we will strive to respond to you sooner, the new deadline for responding to your request is now September 10, 2025. We will make every effort to respond sooner if able to.

You may request that this decision be reviewed by the Information and Privacy Commissioner within 30 days of receipt of this letter. The Commissioner can be reached at:
