

# Victim Impact Statement

Good morning, Your Honor, Your Worship, and/or Mr./Ms./Madame Crown Attorney.

I am here to speak on behalf of Mr. Anthony Heughan, seated here, to assist him in the matter of his charge against Clinical Assistant (C.A.) Mr. Peter Baguma, who horrendously! — and purposely — caused an “Indignity to a Dead Human Body” — his Mother, Josephine Heughan (née Lonsdale). He is too traumatized to do so himself. And I am also a witness.

Peter Baguma was — and still is — employed by “In-Home Assisted Living (IHAL),” and Mr. Heughan personally witnessed — to his horror! — Mr. Baguma smash Mrs. Heughan’s face and head against the metal plate and steel bars of the hospital bed in his haste to leave! Believing Anthony was taking too long hugging and grieving over his Mother’s body, Mr. Baguma’s impatience led him to forcefully rip off Mrs. Heughan’s wrap-around body-diaper so *hard* that the crashing noise of her face hitting the steel plate and bars woke the man in the next bed out of a deep sleep — where he sat bolt upright — alarmed by the shock! When Baguma realized the crime he had just committed, he quickly glanced up from the corner of his eye, saw the look of horror on Mr. Heughan’s face — and immediately grabbed a pillow and jammed it between Mrs. Heughan’s face and the metal plate and bars, in a futile attempt to mitigate his repugnant act!

And yes, Your Honor, I *deliberately* use the word “MURDER” because the two doctors, Michael Sklar and Seema Marwaha, who *deliberately* and illegally changed the “Full Code Resuscitation — using all available methods” — and which had been ordered by the previous ER doctors — to “DNR, Do Not Resuscitate!” — without informing or asking Mr. Heughan’s permission, even though he was sitting right there beside them.

From the moment the ambulance brought her and Mr. Heughan into St. Michael Hospital (a.k.a. St. Murder Hospital) on Friday, July 21st — nearly eight hours had passed! They kept them waiting forever in that Emergency Department’s dark, dank, damp hallway! — while Dr. Sklar walked past them at least six times, turning up his nose at them, like a finicky cat. She died — was killed! — at 2:20 a.m. Sunday morning.... Mr. Heughan never left her bedside, not even for a moment!

As I speak, the two “alleged” doctors are being charged with “Homicide with Malice Aforethought.” Their cases are currently before the courts.

As a witness, Your Honor, I accompanied Mr. Heughan to a meeting requested by hospital staff and members of St. Michael's "medical team," in order to protect him from their attempts to "pick his brain" to find out how much he knew. And, Your Honor, I can assure you that *that is exactly* what they tried to do.

I knew Mrs. Heughan very well. She was a wounded WWII battle front-line nurse, a veteran of the Canadian Women's Army Corps (CWAC), attached to the medical unit, and even survived Hitler's London Blitz as a Red Cross nurse. I have read her medical records — all 200-plus pages — upside down, right side up, forwards and backwards, so I know whereof I speak.

After what Mr. Heughan witnessed, he was encouraged to write his nine-page epistle — based on this horrible experience (including the hospital ordeal of Josephine while she was still alive!) — by former St. Michael's otolaryngologist (ear, nose, and throat specialist) Dr. Oakley Smith, a true Louis Pasteur-type medical man.

Your Honor, no son should ever have to witness the horror, torture, murder and mutilation of his Mother's body, regardless of his age.

Incidentally, Your Honor, it took two long years to finally get the name released of the C.A., Peter Baguma, who bashed Mr. Heughan's mother's head against the metal plate and steel bars of the hospital bed. And that was only because I submitted a "Freedom of Information" form to the government, demanding Samantha Edgar, St. Michael's so-called "Patient Relations Expert," to release Peter Baguma's name to us; which for two years, she refused to do, despite clearly being aware of his actions. Her comment to us in a letter — "I'm so sorry that you had to witness your Mother's head make contact with the bars" — further confirms that she knew exactly what had happened.

So, Your Honor, if the above statement *is not a clear-cut admission that she knew full-well what was going on, then I don't know what would be!* Samantha Edgar (St. Michael's Patient Relations "Expert"), the hospital, the College of Physicians and Surgeons of Ontario (CPSO), In-Home Assisted Living (IHAL), the police, and the courts — all are "dragging their feet" in this matter.
